

Shipping Addendum

Buyer, _____, requests that Bajan Pomeranians ship his/her newly purchased dog/puppy, AKC# _____ to them via airline transport. Buyer understands they are responsible for all fees associated with shipping; including but not limited to airline fees, crate, health certificate, and transportation cost to deliver said dog/puppy to the airport. Buyer agrees to hold Bajan Pomeranians and Michelle Cavanaugh harmless for all causes related to the shipping of this dog/puppy; including hypothermia, hypoglycemia and contagions.

Buyer has read terms of shipping and has had an opportunity to refuse such terms prior to purchasing a dog or puppy from Bajan Pomeranians.

- Buyer understands and agrees that their dog/puppy will not be shipped as cargo in temperatures below 45 degrees nor over 80 degrees. Should Buyer purchase a dog/puppy during a time of year in which shipping does not meet the above criteria, Buyer agrees to wait until shipping is possible. Buyer agrees that Seller may choose to ship dog/puppy by the safest means available including; traveling with said dog/puppy and shipping as carry-on luggage, or driving to an agreed upon destination. Optionally, Buyer may drive or fly into Michigan to pick up their puppy.
- Although Bajan Pomeranians will arrange shipping, smaller airports can be difficult to ship to. Bajan Pomeranians uses two airports, Bishop International in Flint, MI and Detroit Wayne Metro located in Detroit. We only ship via Northwest, Northwest VIP, or Delta airlines. Buyer would like their dog/puppy shipped to _____(City). It is the Buyer's responsibility to confirm that shipping into the city of their choice is possible. **You Must Call the airline!!** Online passenger information does not mean it is possible to ship an animal into any particular airport.
- Buyer requests that Bajan Pomeranians purchase shipping insurance for the transport of this dog/puppy; either by means of Declared Value (apprx. .50 to \$1.75/\$100), or Private Carrier insurance (apprx \$3.75/\$100). Buyer understands they are responsible for this fee.

- Buyer understands that if shipping cannot be arranged to their preferred airport/city, their dog/puppy will be shipped to the next closest airport that services one of the above mentioned airlines.
- Should Buyer wish to arrange their own method of transportation other than airline shipping, Buyer understands that Bajan Pomeranians has the right to refuse any transportation arrangement that is deemed unsafe for the dog/puppy; or inconsistent with the above terms.
- Seller will provide in writing, a breakdown of expected shipping costs (estimate only) that will determine a shipping charge listed on the contract. Buyer acknowledges that the cost of shipping is subject to possible increase above this estimate due to rate change increases by the airline, or other factors outside of the Seller's control. Buyer understands that he/she is still responsible for this and that the any additional amount must be paid prior to shipping.

Buyer agrees to ALL of the above terms and understands this is a binding contract as part of their sales contract with Bajan Pomeranians. By signing below I am indicating that I have read and agree to the above terms in their entirety.
