Further, this dog is being sold up-to-date with all required vaccinations. Bajan Pomeranians are warranted for life against "Black Skin Disease" and for a period of one year against all other genetic or hereditary defects which may render this dog unsuitable as a companion pet, breeding, or show dog. In this instance, a replacement will be given when one becomes available. At no time will a refund be issued. Replacement is the only option. Buyer understands and agrees that no other guarantee, expressed or implied, is given beyond this contract. A non-refundable deposit in the amount of \$ \_\_\_\_\_ holds this dog until \_\_\_\_\_ at which time full payment is due or deposit will be forfeit. Because this dog is being sold as a breeding and/or show quality dog, "Full" AKC registration will be given. This contract is executed in and governed by the laws of the state of Michigan.
